Mysterious Lights Seen-Two mysterious lights, a white one followed within a few minutes by a bluish one, were seen in the sky over the mesa about dusk Sunday evening, according to Dr. R. S. Rightenour, who says that the illumination caught his eye as he entered his car. Mrs. Rightenour, her mother, who lives on the mesa and with whom she was visiting, and several others who were scated on the porch, also saw the illumination, declares Mrs. Rightenour. 
